IV. Status of Funds / Financial Update

Grants Liquidating by 9/30/2025 (PY23):

- All grants are fully spent.

- Adult (Warren County): Remaining funds will be addressed using FIFO. Mark Anderson is assisting to ensure proper reporting.
- Dislocated Worker: 100% spent.
- Youth (Butler County): \$1,018.56 remaining. Entered and being recoded to clear in June.
- Admin Funds: Nearly 100% spent and will close after June.
- OMJ Branding: Counties have provided assurances; bills will reflect in June closing.
- RESEA: 100% spent.
- QUEST: Remaining balance returned to the state.

Grants Liquidating by 9/30/2026 (PY24):

- Adult: 59% spent, 63% obligated. Counties ahead of pace.
- Dislocated Worker: 21% spent, 25% obligated. Recently received additional funding.
- Youth: 29% spent.
- Admin: Expenditures just beginning.
- Rapid Response: Needs to be disbursed.
- State Special Grant: 63% spent, 88% obligated.
- RESEA (PY24): 28% spent, 68% obligated.
- Youth Compliance: Meeting federal guidelines for out-of-school youth, though slightly under board benchmarks.

V. Budgets

- Budget to Actual: Slightly under budget overall but close to target.
- Ohio to Work Budget: No new spending since last meeting.
- Non-Profit Funds: David Fehr requested a tracking document to show when funds are spent from the unrestricted account and what they are spent on. Executive Director Ehling stated that staff will develop an Excel spreadsheet to track and display line items each time money is spent.

VI. Discussion Items

- Fiscal Agent Update: Executive Director Becky Ehling reported that Warren County has decided to discontinue serving as fiscal agent. She has scheduled meetings with Butler County on July 22 to explore alternatives.
