III. Call Meeting to Order (Presenters: Tate Borcoman)

- V. Committee Updates
 - A. Governance Committee (Presenters: Ron Rohlfing)

Committee Chair Ron Rohlfing provided an update on behalf of the Governance Committee. He reported that the committee will begin reviewing the first third of the policies to ensure they are aligned with state requirements. Additionally, he shared that the committee will be reviewing the Board Roster and working to fill the current vacancies.

B. BEST Committee (Presenters: Zach Stanfield)

Committee Chair Zach Stanfield presented an update on behalf of the BEST Committee. He shared that there are no new updates since the Board last met. However, he reported that he and Traci attended a networking event in Clermont County, where they were able to establish several valuable new connections.

C. Budget & Finance Committee (Presenters: David Fehr)

Committee Chair David Fehr presented an update on behalf of the Budget & Finance Committee. He reviewed the dashboards reflecting spending through February 28, 2025. He reported that grants scheduled to liquidate by September 30, 2025, have been fully expended. Grants liquidating by September 30, 2026, have already begun spending and are currently ahead of schedule. Executive Director Ehling shared that the PY2025 budget has been released, and Area 12 will experience a 1.3% decrease in funding. This decrease pertains to grants that will liquidate by September 30, 2027.

D. Emerging Workforce Committee (Presenters: Tonya Stone)

Committee Chair Tonya Stone provided an update on behalf of the Emerging Workforce Committee. She shared that there are no new updates at this time. However, she reported that the committee is actively working on rejuvenating the Youth Focus Group.

E. Education & Training Committee (Presenters: Karen Karnes)

Committee Chair Karen Karnes provided an update on behalf of the Education and Training Committee. She reported that there are no updates at this time, as the committee has not met since the last Board meeting. She noted that the committee is scheduled to meet at the end of the month, at which time they will select a topic for the 4th Annual Workforce Development Forum.

With the committee's approval, Executive Director Ehling was authorized to submit the contract amounts through the Budget & Finance Committee for review and acceptance.

B. Update on Warren County and 501c3

At this time, it is anticipated that BCW will remain under Warren County. Additionally, BCW will not be pursuing a separate bank account for the 501(c)(3) at this time.
