A. Update of Partnership Opportunity - High School Initiative

Easterseals, WC OMJ met with JBM Packaging - Fair Chance Program for formerly incarcerated individuals. Also met with Becky at Vaga, a new Mason Manufacturing Co. regarding Apprenticeship program - connected them to OMJ for Veteran Services. Easterseals awaiting information regarding Juvenile

probation, as they would like to incorporate a pre-apprenticeship program for formerly incarcerated youth.
