Amy explained her role with OMJ and gave an update and what they are working on. She is excited that Ernie Dimalanta is coming to speak about personal branding and small business ownership.

B. Easterseals (Presenters: Callie Amann, Jessica Dean)

Jessica, Callie, and Chelsea explained their roles and what they do with Easterseals Redwood.

Easterseals partnered with Warren County OMJ and hosted a micro job fair last week and it went well.

This week they are partnering with Clermont County OMJ and Supplychain OKI to discuss rolling out a pilot with West Clermont High school. They are looking at starting the eligibility screenings and enrolling the 10 students into the Supplychain OKI and youth programs.

They are also continuing to work with Warren County Aspire to do a similar pilot, creating a gold plan around individuals completing Aspire and getting their GED's while also gaining work experience. They would like to continue to grow this program and expand to other counties.

They are continuing to work with Judge Kirby's attend docket to enroll justice impacted youth in Warren County

C. Aspire (Presenters: Karen Karnes)

Karen explained her role at Aspire and reported they are working to get some issues resolved with a new vendor they are using around the voucher for the GED test.

Aspire is launching a new intergraded education training this winter associated around entrepreneurships and small business classes where students can study and work towards the ESB certification and also take a class to receive an excel credential as well as customer service credential.
